Arlene D. Schiff, Senior Advisor of LIFE & LEGACY® at the Harold Grinspoon Foundation, led us all in a training on writing each organization's Legacy Action Plan, a critical first step to establishing a successful legacy campaign that will be carried out over the next four years and beyond. The workshop concluded with a charge to each agency to draft its own Legacy Action Plan.

#### THE LEGACY COVERSATION AND INTEGRATED ASKS

This workship focuses on the art of guiding a donor conversation to uncover the emotional connection that a legacy prospect has for one or more communal organizations and then asking the prospect to join in ensuring the future of the local Jewish community. This session includes role-plays so participants leave with the confidence they need to begin having conversations. Though securing a legacy commitment differs in many ways from transactional annual campaign conversations, many teams are in fact running multiple campaigns at once. Therefore, the workship also covers how to integrate the ask for multiple purposes.

This workshop begins with each team examining how they already communicate with their donors and provides examples as to ways to integrate legacy marketing into exisiting marketing efforts. Additionally, information is provided as to how organizations can create their own legacy marketing that is effective and donor-centered.
