UPDATES FROM THE HAROLD GRINSPOON FOUNDATION

New Life & Legacy[®] Branding



This year, on the heels of the 10th anniversary of Life & Legacy, the Harold Grinspoon Foundation has updated the logo and branding materials for the initiative, giving the national program a fresh look for the next decade and affording communities more flexibility with the logo and tagline.

While we mostly use our own name and logo here in Greater New Haven—Create a Jewish Legacy—we wanted to be sure you were aware of the updated Life & Legacy branding if you do have occasion to use it. When using the Life & Legacy name and/or logo, please keep the following standards in mind:

- "Life & Legacy" should always be written in title case as seen here and not in all capital letters, as the previous logo
- Always use the ampersand "&" and not the word "and" when writing out the name of the program
- The updated tagline is: "Assure Jewish Tomorrows"
- "A program of the Harold Grinspoon Foundation" is no longer part of the tagline and should not be included as part of the logo


